# Quarterly Program Report of Sensitization and Prevention of Violence Against School going Children July to September, 2019

#### I. Introduction:

Sensitization and Prevention of Violence Against School going Children (VASC) in Tamil Nadu is a new initiative that aims to sensitize all Government functionaries engaged with children in Schools, Hostels and any type of Child Care Institutions or Child related institutions. By monitoring and documenting cases of Child Rights violation against School going children; dissemination of Child Rights Violations reported in Tamil Nadu to the District Level Officials, State Commissions and Institutions; intervention by sending complaints and submitting RTIs to the concerned authorities; undertaking advocacy efforts with Government authorities at the district, and state levels working with school going children; by providing legal intervention for and on behalf of victim' children and by undertaking lobbying efforts with Members of the Legislative Assembly for bringing about policy changes through interventions coinciding with the Sessions of the Legislative Assembly.

#### II. Activities of the Program:

#### 1. Online monitoring of Violence Against School Going Children – On a Daily Basis:

In the Project Office, staff have been deputed to perform "Online Monitoring on a Daily Basis". The news items collected from the publications are all on the types of Violence against Children and School going Children. These news items are to be catalogued and sorted into various categories, one of them being Violence Against School Going Children (VASC) for which special attention is given while collecting intimations. These VASC intimations are then sent to the State Program Coordinator on a daily basis. The intimation received from the Online monitoring Staff is then reviewed by the State Program Coordinator to decide on the extent of intervention that the Violence against Children and School going Children will initiate. The monthly intimation data are disseminated to concerned Government Officials through email once every month. From July to September, 2019 the number of VAC Violations recorded is 321.

# V. State Level Advocacy and Campaign Activities:

- The State Program Coordinator and Trichy Regional Coordinator have visited the Trust for Rural Development Organization located at Kavalkaranpatti Village, Thogamalai, Karur District for discussing the issues in the Mahatma Gandhi National Rural Employment Guarantee Scheme on 31.07.2019. We also met the director, Ms.Ursula and his team members to understand the issues behind in implementation of the Scheme.
- The Regional Coordinator has a good rapport with the District Chief Education Officer (CEO). He met him and discussed about the POCSO cases in the Government schools. The CEO was more concerned about the issues of POCSO in the school premises. He requested our team to organize an exclusive training for all the High School Headmasters on POCSO Act. Hence, our team organized the, "One Day Sensitization Training Program on POCSO Act to the High School Head Masters in Dharmapuri District" on 17th August 2019. More than 120 headmasters have participated in this program. All the District Level Child Protection Officials like, Chairperson of the Child Welfare Committee, District Child Protection Officer, Child Line, District Social Welfare Officer, Chief Education Officer and Two Judges from the District Legal Service Authority have participated in this program.

 The State Program Coordinator was invited to deliver the address on POCSO Act to the Dstrict Coordinators of the Child Friendly School Forum on 28.09.2019 at Pollachi, Coimbatore District.

# VI. Follow Up Intervention - "Sitting of NCPCR Bench":

National Commission for Protection of Child Rights conducted a "Sitting of NCPCR Bench" at Ramanathapuram, Tamil Nadu on 21.06.2019. The honourable Chairperson of NCPCR Ms.Priyankarora and a member as well as Chairperson of SCPCR Ms.Nirmala IAS (Rtd) and members, District Collectors of Ramanathapuram and Sivagangai and Police Superintendent of Ramanathapuram took part in the "Sitting of NCPCR Bench." We already submitted a memorandum to the Chairperson of the NCPCR. This event has been recorded in the last quarter report. The follow up action initiated in this quarter. We have sent RTI Applications to the National Commission for Protection of Child Rights (NCPCR) and State Commission for Protection of Child Rights (SCPCR). We also got partial responses from the both the institutions. We have sent communication to both the institutions requesting to get the complete details.

#### VI. Preparing Projected Activities of VAC at 2020:

To ensure that child rights in the entire state are timely and effectively monitored and acted upon by the different institutions that have been specially created, staffed and funded for this purpose. Mainly the following institutions will be monitored by us.

#### II. Activities proposed in the year 2020:

Through information sought under the Right to Information Act, 2005

- Undertake interventions with these institutions on specific cases of violence against children.
- Monitoring of the working of these institutions through reports released with factual information.
- Public Interest Litigations initiated pro bono on the issue of child rights protection at the High Court on various issues that are highlighted during the monitoring of working of these institutions
- 2. Advocacy efforts will be undertaken with Parliamentarians and Legislators to raise issues regarding violence against children and the working of child rights protection bodies in Parliament and state legislature.
- 3. Fact Finding will be done in crucial and important cases regarding violence against children.
- 4. Work closely along with the respective District Legal Services Authorities to ensure free legal representation for all victims in case of violence against children.
- 5. Annual and periodic reports of this monitoring experience undertaken will be made available in English and the regional language and then made available as print copies but more shared in the social media for wide circulation.

#### V. Impact:

- Federation of Organizations Fighting Violence Against Children was formed by the NGOs,
  Movements and individual activists working for child protection and child rights in
  Dharmapuri, Salem, Thiruchirapalli, Perambalur, Sivagangai, Ramanathapuram districts.
  This federation representatives met the Government officials once in a month and
  submited the memorandum / complaint to take action against the Violence Against
  Children's issues.
- 2. In our teacher's training, one of the participants have expressed that the training has ensured a deeper understanding of how to better handle children in class. The teachers have shifted from looking at them as "students" to looking at them as "children". The teachers have realized that they need to spend time with each of their students both inside and outside their classrooms. The significance of understanding the socioeconomic background of the child has been realized.
- 3. The Regional Coordinators had maintained an upright rapport in a monitoring manner with child protection officials as a result, it confirmed their intervention to stop violations against children in all possible ways.
- 4. Based on the success of the previous training program with the De La Salle Brothers (DLS) and they independently assessed the impact of the programs, they approached us and requested to conduct the same pattern of the training programs for their students, teachers, Children Home Mothers, Managers, Hostel Wardens on Child Protection.
- 5. This new phase of the training program's content has been simplified due to the heterogeneous group of participants like, teachers, Child Home mothers, managers, hostel wardens. This simplified content with the participatory methodology has highly impressed all the participants. Our team received a positive feedback from the participants and the organisers.
