(October 2020 to December 2020)

1. Introduction:

Sensitization and Prevention of Violence Against School going Children (VASC) in Tamil Nadu is a new initiative that aims to sensitize all Government functionaries engaged with children in Schools, Hostels and any type of Child Care Institutions or Child related institutions. By monitoring and documenting cases of Child Rights violation against School going children; dissemination of Child Rights Violations reported in Tamil Nadu to the District Level Officials, State Commissions and Institutions; intervention by sending complaints and submitting RTIs to the concerned authorities; undertaking advocacy efforts with Government authorities at the district, and state levels working with school going children; by providing legal intervention for and on behalf of victim' children and by undertaking lobbying efforts with the Members of the Legislative Assembly for bringing about policy changes through interventions coinciding with the Sessions of the Legislative Assembly.

2. Activities of the Program:

The COVID-19 pandemic is a disease caused by the novel coronavirus. International emergency has been declared as the disease is spreading at an alarming level. Since the outbreak of COVID-19 pandemic in India, the unprecedented nationwide lockdown has been extended from time to time since 24.3.2020. And so we need to prepare well to face the challenge and threat posed by the growing pandemic of COVID-19 the Corona Virus. Accordingly, we have been engaged and accommodated ourselves in our work in this life threatening situation.

2.1.VAC Intimation Compilation and Dissemination:

- 1. The Regional Coordinators have been involved in the compilation of VAC issues with the guidance of the Documentation Officer.
- 2. The documentation officer has got the VAC related intimations and circulated to the State Coordinator and others on a daily basis.
- 3. The State Coordinator has collaged all the VAC press clippings into one page or two page views and circulated to the child rights groups in an image format. We have received positive feedback about the compilation.
- 4. From this quarter, the Documentation officer has prepared a weekly intimation status in a tabular form. The state coordinator has prepared a covering letter and it was disseminated to all the District Legal Service Authorities in Tamil Nadu through email.

Online monitoring of Violence Against School Going Children – On a Daily Basis:

In the Project Office, staff have been deputed to perform **"Online Monitoring on a Daily Basis"**. The news items collected from the media are all on the types of Violence against Children and School going Children. These news items are to be catalogued and sorted into various categories, one of them being Violence Against School Going Children (VASC) for which special attention is given while collecting intimations. The monthly intimation data are disseminated to the respective District Legal Service Authorities through email once a week. During the period of October – December 2020 the total number of VAC Violations recorded is 603.

2.4.District Level Interventions:

During the corona pandemic period our Regional Coordinator had undertaken the following fact findings and interventions:

- Renuga daughter of Thayalan (late), Davamani from Dhandapani Nagar, Oottathur village, Lalgudi Block, Trichy District is studying plus two in Government Hr. Sec. School, Padallur. During the corona pandemic period she went to her relative's home in Sengalpatti. On 11.10.2020 she went missing from her relative's home. This information was brought to the attention of the Regional Coordinator. Our Regional Coordinator has immediately conveyed the same to the Inspector of "Anti Child Trafficking Unit (ACTU)." Uppiliyapuram police enquired and registered a case (Cr.No:1053/2020) at once.
- 2. Trichy Regional Coordinator has received the intimation of "a mother planning to sell her girl Child". He immediately informed the ChildLine and also urged to rescue the child immediately. A team of officials went to the house and inquired about the issue and rescued the child and provided safe protection on 11.10.2020 (Trichy, Manachanallur) as well.
- 3. Sowmiya is studying B.COM in Nehru Memorial College, in Trichy District. She is a 17 year old girl and she was planning to marry Naveen son of Chandra from Thuraiyur on 18.10.2020. On receiving the information of Child Marriage our Regional Coordinator & Child Line Coordinator went to the spot and stopped the Child Marriage and rescued the girl. She was produced before the Child Welfare Committee and was asked to stay in the Child Care home.
- 4. Trichy Regional Coordinator intervened in a Child Marriage case in Andhanallur, Trichy on 23.10.2020 and due to his intervention with the Childline officials the child was rescued and protected.

- 5. A 15 year old girl namely Lavanya is studying 10th standard and living with her parents in Periyakaruppur Panchayat, Andanallur Block, Trichy District. She eloped with Ilayaraja s/o Mariyappan from the same village. Both of them are living together in Mariyappan's house. The girl's parents did not take care of the girl child. This information was brought to the attention of the Regional Coordinator who immediately conveyed the same to the Child Line. Then Our Regional Coordinator and Child Line coordinator went to the spot and rescued the girl and produced her before the Child Welfare Committee on 19.11.2020.
- 6. A 16 year old girl from Malavali Village, Udayarpalayam, Ariyalur District is studying plus one in Government Hr. Sec. School, Serundhapuram. She has been in a love affair with Vetri s/o Karunanidhi from the same village. Both of them planned to marry in Samayapuram Amman Temple. This information was brought to the attention of the Regional Coordinator who at once informed the Child Line as well as Samayapuram Police Station. As a result respective officials went to the spot and rescued the girl and produced before the Trichy Child Welfare Committee (CWC) then the girl was transferred to Ariyalur Child Welfare Committee (CWC) on 20.11.2020.
- 7. Jeevitha is studying plus two in Government Girls Hr. Sec. School Thapettai, Trichy district and living with her parents. Child marriage was solemnized between Jeevitha and Dhanapal from Paithamparai village. Hearing the information immediately our Regional Coordinator and Child Line Coordinator went to the spot and stopped the Child Marriage. The girl was rescued and produced before the Child Welfare Committee and sent to stay in a Child Care home on 4.12.2020.
- 8. Somesh is a 2 year old boy s/o Priya from Yercaud, Salem District. There is a problem between husband and wife, so Priya threatens her husband that she will kill the 2 year old boy Somesh. This information was brought to the attention of the Regional Coordinator. Immediately he filed a complaint to

the Child Welfare Committee, District Legal Service Authority. As a result the 2 year old boy was rescued and handed over to his father.

- 9. A newborn girl baby was thrown away into the garbage and it was found by the local people. The information was brought to the attention of the Regional Coordinator through a phone call from a local activist. He immediately complained to the Anti Traffick Unit and Childline. They immediately went to the spot and rescued the baby and got it treated in the Trichy Government Hospital.
- 10. Sampoornam 16/2020 is a drop out student, living in Thumbalam. Child marriage was solemnized between Sampoornam and one boy. Hearing the information our Regional Coordinator & Child Line Coordinator went to the spot and stopped the Child Marriage. The girl was produced before the Child Welfare Committee and sent to stay in a Child Care home on 05.12.2020.
- 11. Trichy Regional Coordinator intervened in a POCSO case of 17 year old girl child sexual abuse case at Eachampatti, near Manachanallur. Among the three accused police arrested one of their therefore he continually insisted that the local police arrest the other two without further delay.
- 12. Amutha is a 16 year old girl, studying 10th standard from Bikili Panchayat, Pennagaram Taluk, Dharmapuri District. She got married to Shanmugam s/o Ammasi Chinna Pillai on 27.11.2020. This information was brought to the attention of the Regional Coordinator who immediately conveyed the same to the Child Line officials and went to the spot and rescued the girl.

III. Campaign Activities:

We worked in an organized manner and active way towards a particular goal typically for common social cause given below:

National Education Policy 2020 (NEP)- Joint Action Campaign Activities: (Federation For Protection of Education – TamilNadu and Pudhucherry) Education is the basis for the development of a nation. A country which stoutly protects its value system, individuality, history, tradition and cultural standards alone can prosper in this competitive world. When the education was in the State list in the past, States all over India comparatively catered to the needs of the people. On the contrary the New National Education Policy is inversely different. Obviously unified effort alone is the need of the hour to combat the NEP. Therefore, people should mobilize mass struggles and give political pressure to all political parties and societal pressure to movements, organiazations, academics and so on. Then only we can achieve this lofty ideal.

The State Coordinator discussed with the Core Team members regarding the next course of action. Then, we organized a Planning Meeting on 11th October with the core team members to plan the next course of action. Then we organized a Planning Meeting on 13th October with the core team members to finalise the action plan. Thereafter, we organized Planning Meeting on 17th October with the core team members to plan the next course of action.

IV. Impact:

- A newborn girl baby was thrown away into the garbage and it was founded by the local people. The information was brought to the attention of the Regional Coordinator over a phone call from a local activist. He immediately undertook needed action and safely rescued the baby. The abandoned girl baby was handed over to a Specialized Adoption Agency viz., SOCSEAD.
- Trichy Regional Coordinator intervened in a POCSO case of a 17 year old girl at Eachampatti, near Manachanallur. Because of our intervention all the three accused were arrested in connection with the sexual abuse.
- 3) The National Commission for Protection of Child Rights (NCPCR) directed 8 states on 28th Sep 2020 that account for 70% of children in care homes to ensure their return to their families. As per the instruction of the Director, we had a discussion with Adv.Martin consequently the State Coordinator prepared relevant "Legal provisions to challenge the order of the NCPCR." We

also discussed this issue with "HAQ," a National level Child Rights Organization team and requested them to issue a statement against the order of the NCPCR. They issued a joint statement condemning the stand taken by the NCPCR.
